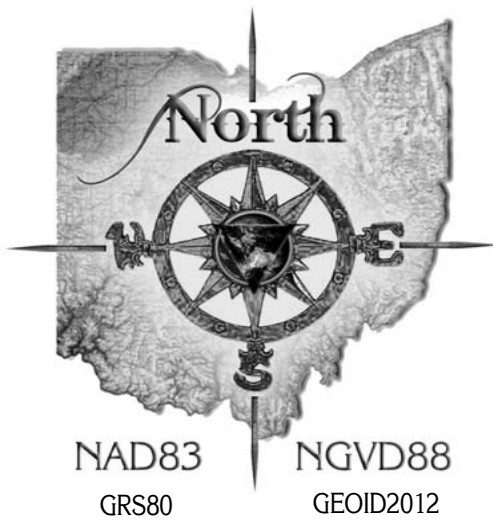

ODOT CORS/VRS NETWORK



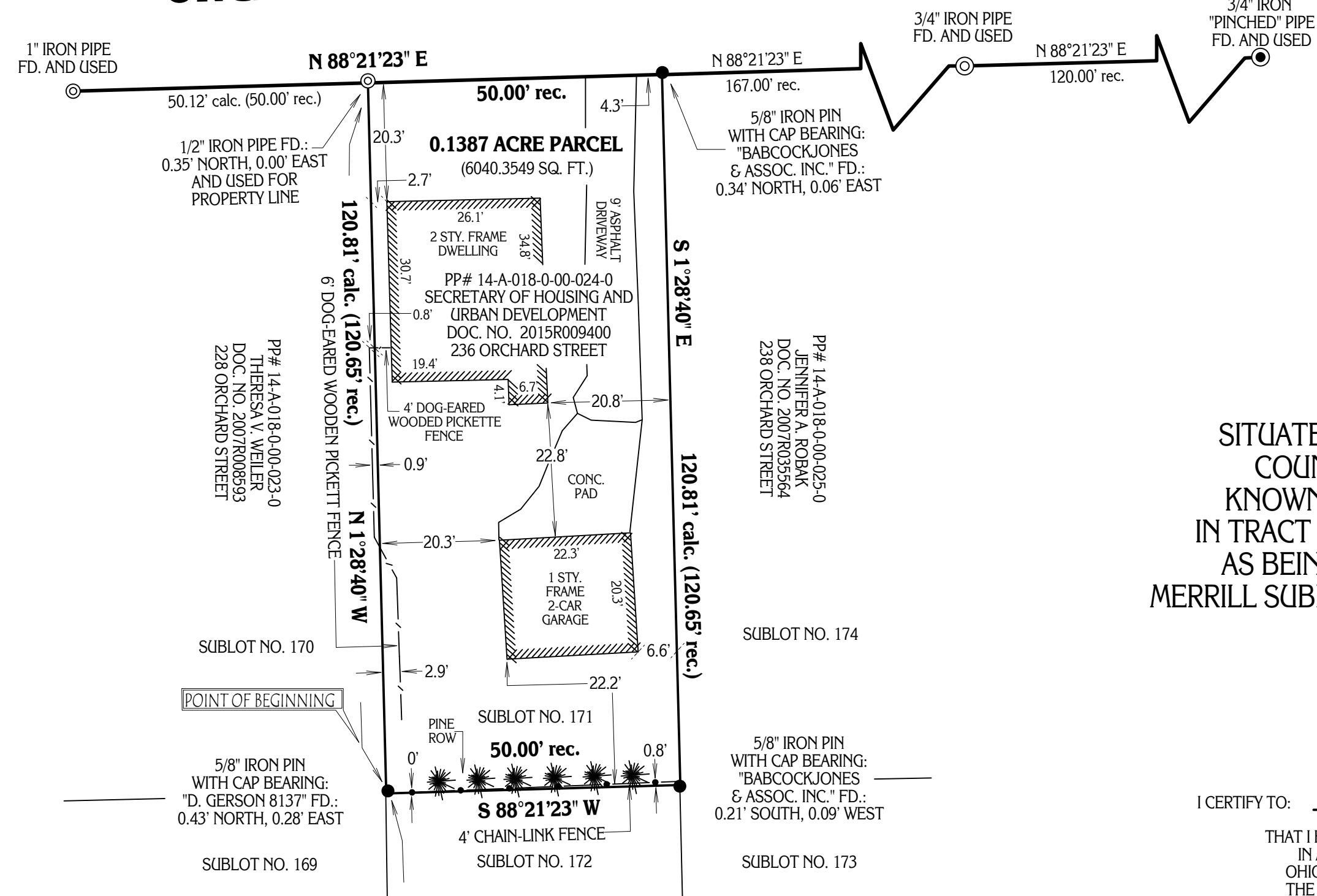

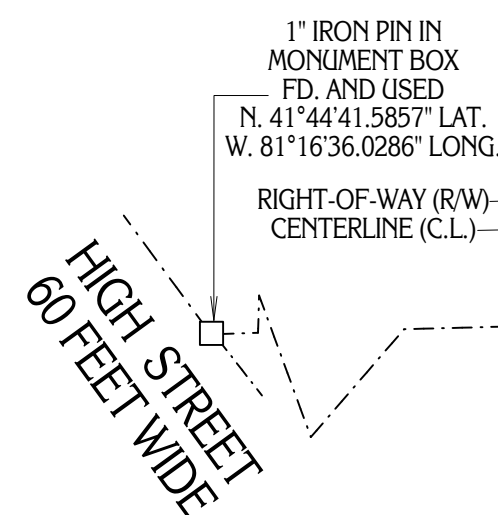
