

## Re-Survey of Land now or formerly owned by Norman C. Miller PN: 03-009-00-071-00 OR Book 724 Page 1498 6.097 acres

Situated in the Township of Ashtabula, County of Ashtabula, State of Ohio, being part of Lot Number 1, Section 3, within said Township, and Township 13 North, Range 3 West of the Connecticut Western Reserve: Beginning at the point of intersection of the centerline of South Ridge Road (60') (SR-84) with the centerline of Erie Ridge Avenue (60'), said point being South 63°35'26" West along the centerline of South Ridge Road, a distance of 149.77 feet, from a 1" iron pin found in a monument box assembly in the centerline of South Ridge Road. Thence South 63°35'26" West along the centerline of South Ridge Road, a distance of 223.33 feet to a point, said point being the northwest corner of land now or formerly owned by Sean P. Wasson PN: 03-009-00-070-00, as recorded in OR Book 297 Page 796 in Ashtabula County Record of Deed (ACRD). Said point being the **Place of Beginning** of the parcel herein described.

Thence **South 00°15'37" East** along the West line of PN: 03-009-00-070-00, aforementioned and the West line of land now or formerly owned by Cortland Meadows, LLC, PN: 03-009-00-069-01, as recorded in OR Book 641 Page 1866 (ACRD), passing through a 5/8" iron pin in concrete found at 36.66 feet, a total distance of **942.45 feet** to a point, said point being the southwest corner of PN: 03-009-00-069-01, aforementioned, said point being on the North line of land now or formerly owned by Alix B. Hill, PN: 03-016-00-002-01, as recorded in OR Book 743 Page 2515, (ACRD), said point being on the North line of Lot Number 5, said point witnessed by a 1" iron pipe found.

Thence **North 89°19'06" West** along the North line of PN: 03-016-00-002-01, and the North line of Lot Number 5, a distance of **306.82 feet** to a point, said point being the southeast corner of land now or formerly owned by Penny G. Walker and Stephen J. Nine, PN: 03-009-00-072-00, as recorded in OR Book 645 Page 971, (ACRD), said point witnessed by a 5/8" iron pin "Slay" found.

Thence **North 00°19'27" West** along the East line of PN: 03-009-00-072-00, aforementioned, a distance of **786.37 feet** to a point in the centerline of South Ridge Road, passing through a 5/8" iron pin "Slay" found 33.61 feet therefrom.

Thence **North 63°35'26" East** along the centerline of South Ridge Road, a distance of **342.73 feet** to a point, said point being the Place of Beginning, and containing **6.097 total acres** of land, 0.236 acres within the right of way, be the same more or less, but subject to all legal highways, pursuant to a Survey (3037) dated October 2021, by O'Hara Land Surveying, L.L.C. and Thomas J. O'Hara, Ohio Registered Surveyor No. 7995.

The basis of bearings used hereon are based upon True North utilizing the Ohio Department of Transportation CORS GNSS Network. Distances are shown as U.S. Foot and decimal parts thereof.

The intent of this description is to describe all of the land now owned by Norman C. Miller, PN: 03-009-00-071-00, as recorded in OR Book 724 Page 1498, as recorded in Ashtabula County Record of Deeds. All iron pins noted as being set are 5/8" x 30" long steel rebar, bearing a plastic cap "OHARA 7995".
