




Deed of Record: Permanent Parcel Number (PPN) 25-033-00-00-008-000 and PPN 25-033-00-00-009-000, Larry Hermann and Laurel Herman Instrument Number (INST) 202207905 and INST 202212233 of Portage County Records and Deeds (PCRD). 9415 State Route 305 and 9443 State Route 305.

Situated in the Township of Nelson, County of Portage and State of Ohio and known as being part of Original Lot 33 with said Township and Township 5N, Range 6W in the Connecticut Western Reserve and bounded and described as follows:

Beginning at the centerline intersection of Hiram-Southington-Hartford Road (also known as being State Route 305, 66 feet wide) and Parkman Road (also known as being Township Road 299, 66 feet wide), referenced by a 6" concrete monument with a 4" brass cap bearing "PORTAGE COUNTY SURVEY MARKER" found North 51°08'23" West, 11.44 feet therefrom.

Thence North 89°37'33" East, along the centerline of said Hiram-Southington-Hartford Road, passing through a 5/8" iron pin with cap bearing "C.H. McGUIRE P.S. 7770" found at 133.58 feet, a total distance of 180.61 feet to a 1" iron pin in a monument box found on the east line of PPN 25-031-00-009-000 as conveyed to Nelson Township Trustees (no deed was found), being the southwesterly corner of the parcel herein described and **The Principal Place of Beginning of this Survey**.

Thence North 00°13'30" West, along said easterly line, passing through a 5/8 iron pin set at 33.00 feet and passing by a 1/2" iron pipe found 0.28 feet west of the property line at 33.82 feet, a total distance of 181.27 feet to a 1/2" iron pipe found at a northeasterly corner thereof, on the southerly line of PPN 25-033-00-00-007-000 as conveyed to Larry Hermann and Laurel B. Hermann, recorded in INST 202215777 of PCRD, being a northwesterly corner of the parcel herein described.

Thence North 89°47'40" East, along said southerly line of Hermann's land, passing through a 5/8" iron pin with cap bearing "C.H. McGuire R.L.S. 7770" found at 161.87 feet, a total distance of 163.31 feet to a 5/8" iron pin set at the southeasterly corner thereof.

Thence North 00°04'15" East, along the easterly line of said Hermann's land, along the easterly line of PPN 25-033-00-00-005-000 as conveyed to Robert J. Moss and Vickie S. Moss, recorded in INST 200801362 of PCRD, passing by a 1/2" iron pipe found 0.64 feet west of the property line at 317.75 feet, passing through a 5/8" iron pin with cap bearing "C.H. McGUIRE P.S. 7770" found at 642.93 feet and used as a corner reference, a total distance of 643.58 feet to the northeasterly corner thereof on the southerly line of PPN 25-033-00-00-004-000 as conveyed to Martin R. Miller, recorded in INST 200613336 of PCRD, being a northwesterly corner of the parcel herein described.

Thence North 89°38'49" East, along said southerly line of Miller's land, along a southerly line of PPN 25-033-00-00-015-000 as conveyed to Adam R. Yoder, recorded in INST 202306692 of PCRD, passing by a 3/4" iron pipe found 0.15' north of the property line at 394.53 feet, a total distance of 585.79 feet to a 4" X 10" stone with an engraved "T" found, being the northeasterly corner of the parcel herein described.

Thence South 00°55'59" East, along a westerly line of said Yoder's land and also along the westerly line of PPN 25-033-00-00-011-000 as conveyed to Daniel W. Childers, recorded in Volume 1068, Page 236 of PCRD, passing by a 5" x 9" stone with an engraved "+" found 0.68 feet west of the property line at 32.21 feet, a total distance of 569.39 feet to a 5/8" iron pin with cap bearing "C.H. McGUIRE R.L.S. 7770" found at the northeasterly corner of PPN 25-033-00-00-010-000 as conveyed to Charles E. Fackler and Sandra J. Fackler, recorded in INST 200330326 of PCRD, being a southeasterly corner of the parcel herein described.

Thence South 89°42'43" West, along the northerly line of said Fackler's land, 210.11 feet to a 1" iron pin found at the northwesterly corner thereof.

Thence South 00°57'40" East, along the westerly line of said Fackler's land, passing through a 5/8" iron pin with cap bearing "C.H. McGUIRE P.S. 7770" found at 221.72 feet, a 5/8" iron pin set at 222.10 feet, a total distance of 255.10 feet to the southwesterly corner thereof, on the centerline of the aforesaid Hiram-Southington-Hartford Road, being a southeasterly corner of the parcel herein described.

Thence South 89°37'33" West, along said centerline, a frontage distance of 552.63 feet to <u>The Principal Place of Beginning of this Survey</u> and containing 10.668 acres of land, of which, 0.418 acres are within the R/W of said Hiram-Southington-Hartford Road, leaving 10.250 acres of land exclusive of said R/W, surveyed in April of 2023 by D.B. Kosie and Associates (Robert L. Kosie, Registered Professional Land Surveyor No. 8167). Bearings are to True North using The ODOT VRS and CORS GNSS network (NAD83 - 2011, NAVD88, GRS80, and Geoid18). Be the same, more or less, but subject to all legal highways, conditions, assignments, agreements, easements, restrictions and encumbrances.

The intent of this survey is to combined PPN 25-033-00-00-008-000 as conveyed to Larry Hermann and Laurel Herman, recorded in INST 202207905 together with PPN 25-033-00-00-009-000 as conveyed to Larry I. Hermann and Laurel B. Hermann, recorded in INST 202212233 of PCRD.
