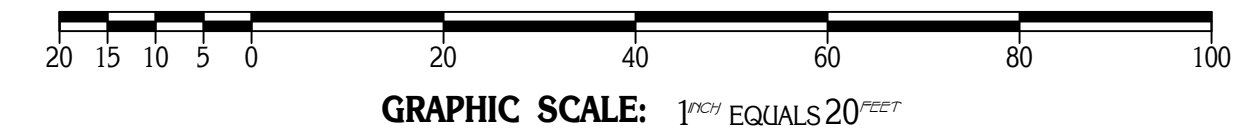
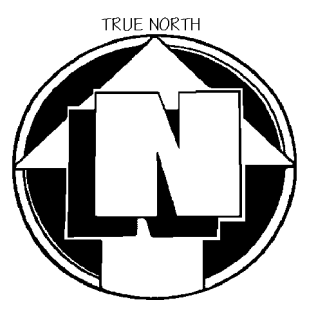


BASIS OF RESEARCH AND RECORDS

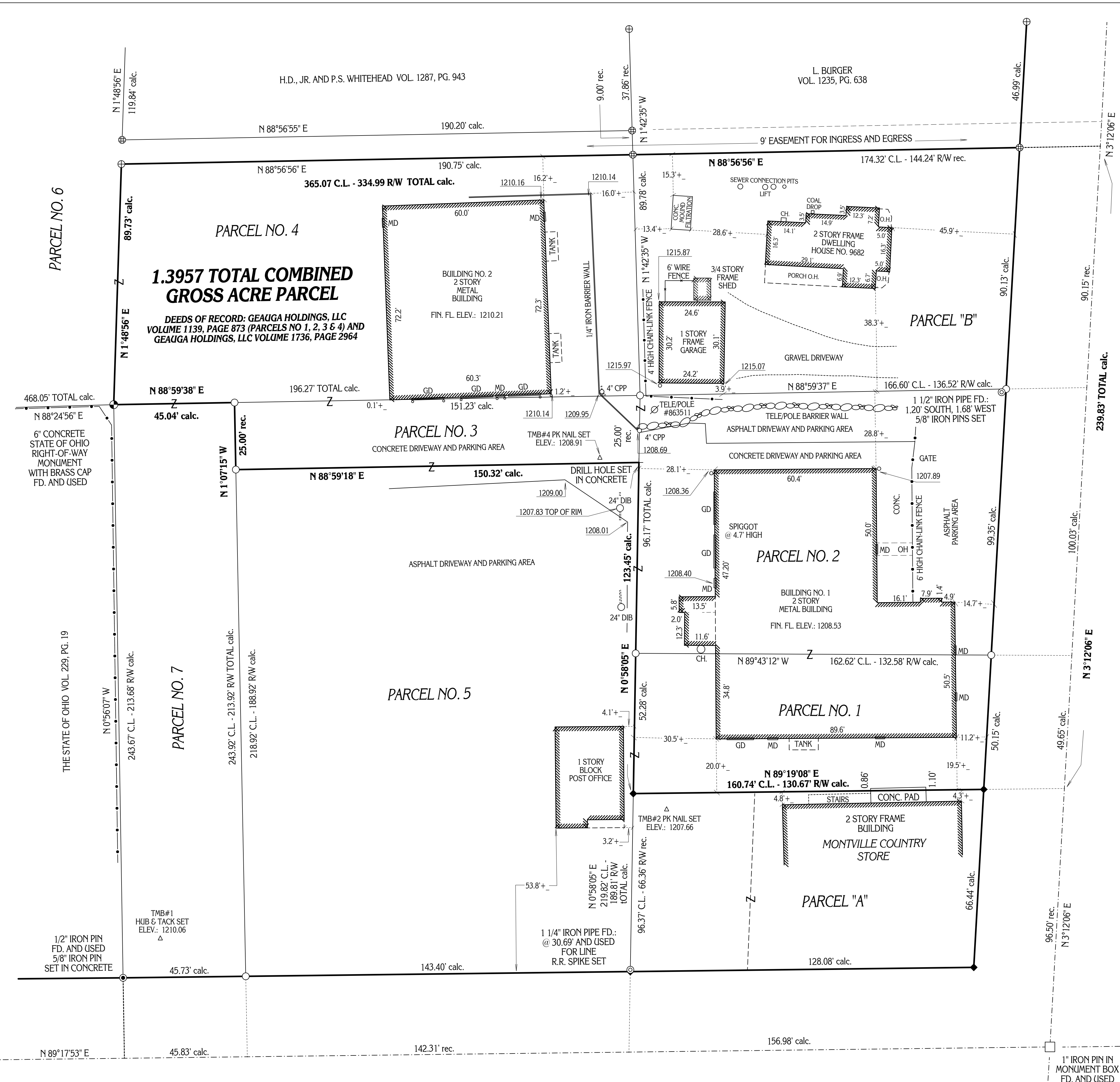
